By signing this Agreement, you are retaining Elika Associates Inc to act as your agent for the rental of an apartment within New York City upon the following terms and conditions. Although we cannot guarantee that we will find you exactly what you are looking for, we wish to assure you that we will be representing you and not the landlord. As such, we will be using our best efforts to find you a suitable apartment for the best possible price.

If within 120 days after we have shown you an apartment, you rent that apartment or any other apartment in the building or complex which was shown to you by us, you agree to pay us a commission ("Commission") equal to fifteen (15%) percent of the first twelve (12) months' rent. You will pay us the entire Commission (by certified, bank check or money order) upon the earlier of your execution of a lease or other agreement. You acknowledge that in certain instances Elika Associates may receive additional compensation from the landlord. Should that happen, you still will be responsible to pay us our full Commission.

In the event that within that 120 day period after we have shown you an apartment, you rent that or another apartment in the same building or complex through the services of a broker other than Elika Associates Inc or through the landlord directly, you will nonetheless pay us the entire Commission.

In the event of your default under this Agreement, in addition to paying us our entire Commission, you will pay us all reasonable legal fees incurred by us in enforcing our rights. In addition, any claim that you may have arising from the services provided to you by Elika Associates Inc shall be limited to the amount of the brokerage commission paid. This Agreement is the entire agreement between us concerning the subject matter and may not be changed except by a further signed writing.
